BAWA, like everybody else in the world, is suffering from rising costs and tightening income streams. Whilst it is

not the aim of the association to make a profit it is important that we don't make a loss. Unfortunately, at this year's AGM we will be reporting a loss. However, I can report that all members of the Management Committee, guided by the Treasurer and Executive Officer, are working very hard to turn this situation around and are all determined to balance our books for 2012-2013. Unfortunately, costs will rise but not excessively. Furthermore, we are determined that an equal amount of savings will contribute towards the balancing of the books.

BAWA, as many of you may know, has 33 members, our affiliated clubs: it has no individual members and, as such, is limited in its ability to players. services The to primary responsibility of bridge delivery rests with our member clubs. Constitutionally BAWA responsible for running State Selection events and State Championships. We also run, under license from the ABF, four Gold Point events. Naturally we are also willing to assist clubs in any way that we can. I mention this because John Aguino's article in the last Focus pointed out that over 40% of our 4136 registered players have less than 15 master points and over 90% have less than 300 master points. So what can we offer these players? The BAWA Tournament Committee is working hard on next year's


These competitions are usually followed with light refreshments, served with fruit juice, wine & beer. Enjoyed by all the members and great way to finish off a happy days bridge.

### Albany Bridge Club

Re: Your June Issue of Focus, in which Mr. Mike Trafalski wrote an article about the building of the Albany Bridge Club.

I can only conclude that Mr. Trafalski was writing about the building of the additional room at the club and not the Bridge Club itself. I would therefore like to put the record straight.

In 1996 we were warned that we would have to leave our premises in Port Road. A former President of the club Mr. David Fitzgibbon has the forethought to set money aside as a building fund, but the President at the time of our being giving notice, Mr. Ross Anderson, could see no alternative but to build a room onto the Bowling Club at Emu Point. This would have meant the giving all of our revenue over to them and having to ask the Bowling Club Committee anytime that we may have needed anything.

I had always fervently believed that it was in our power to build our own Clubhouse and hated the thought of giving up our independence. Several other members of the Club supported me but it was not until Mrs. Enid Home, a Freeman of the City of Albany and a much respected figure, asked me to put my name forward as President, that any progress could be made. With her help and influence, I was elected President and set about the task of building the Clubhouse.

First, Mrs. Enid Home applied to the City of Albany for land to build on and we were granted a patch of land that had been grated to the children of Albany by Queen Victoria but which had lain idle for years because it was too small to use as a play area. Mrs. Home also applied to various bodies for financial help and told me how to apply to the Lotteries Commission for still further funding. This I did and this along with the money already set aside in the Club's 'Building Fund' was enough to build our own Clubhouse.

The builder we chose was Mr. Peter Cooper. His estimate was the cheapest; he had played on the land as a child and assured me that he would dearly love to be the builder. Mrs. Kay Thompson,

the Club Treasurer, vouched for his integrity and she was a tower of strength to me throughout the whole process. The Club Secretary Mrs. Rita Leeming, also a tower of strength, along with Kay chose the colour scheme and general decoration.

I visited the site everyday during construction to keep in touch with Mr. Cooper, who finished on time and within budget.

The Clubhouse was opened in September 1998 with three Members of Parliament present.

# **Bridge Etiquette**

## **Systems and System Cards**

By Suzanne Goodall

While we are not required to have system cards at the table here in Western Australia there are many places where they are required for any event.

Having said this we all should know that a card is required for all Red and Gold point events. It should be complete and hopefully legible. I have seen some which more closely resemble hieroglyphics than English. Also it is important that your card is identical to your partner's.

It is a good idea to have a completed system card for every partner with whom you regularly play. This way prior to the session you can review the card to refresh your memory as to your agreements. (If you are not certain as to how to complete a simple system card then may I suggest you ask an experienced player to help you.)

Also, the Australian Bridge Federation has a Convention Card Editor. If you download this you will find making new cards and/or changes so much easier than hand writing each card.

Of course some serious partnerships not only have a fully completed system cards but also a comprehensive set of notes to outline their various systemic agreements. This can be a good way to fine tune what you play.

Let me now say that most players should be able to play quite competently with only a simple system in place. The majority of hands are what I call 'bread and butter' bridge and there is simply no need for gadgets and gizmos. If you have a good foundation in the basics you will usually reach the correct contract.

I have seen reasonably competent bridge players come unstuck as they try to juggle too many complicated conventions and concepts.

You have an obligation to know your system and offer the correct explanation should your opponents enquire. Therefore if you are playing Mixie Twos and Transylvanian Threes be prepared to give a clear and concise answer to all enquiries. If you repeatedly forget or give the

wrong explanation then the Director can require you simplify your system and delete those gadgets. This in my opinion could be a wise move for all concerned. For some players back to basics is the key.

When asked about the meanings of a bid and you have not discussed that particular bid, simply say 'not discussed. If you know you have an agreement but have forgotten what the meaning is then see the director. You will be asked to leave the table while your partner explains the meaning of the bid to the opposition. Note that there has been a small amount of unauthorized information in that it is apparent that you have forgotten. Your partner must avoid acting on that knowledge which would clearly be unethical.

It is very important that you avoid at all costs such expressions as 'I'm taking it as...' and 'I think it is......' Both of these methods of answering give your partner information. So your options are 1) to explain the agreement or 2) to tell the opponents that this sequence has not been discussed or 3) summon or see the director if you have forgotten.

If at the end of the auction you are defending and partner has given the wrong explanation, failed to alert or otherwise has your system wrong DO NOT draw attention to it until AFTER the play of the hand is finished. The obvious reason for this is that you would be exchanging information which could help in the defence. After the play call the Director who will determine whether the incorrect information or failure to alert has caused damage to the opposing side.


On the other hand if you are either Declarer or Dummy before the OPP select their opening lead be sure to correct any information that is wrong or a failure to alert. Technically this should be done in the Director's presence although the integrity of the bidding is protected as long as it is done.

So in closing no matter which system and conventions you choose to play ensure that you know your system.

# **Team Scoring**

I believe that one of the reasons that Bridge is so popular across the board is that it is a game of outstanding logic, that helps people keep their minds sharp and active. This applies equally to the 'young guns', and those of us who are well into our more mature years.

However, sometimes rules are made - or, more accurately, scoring systems incorporated - that seem to defy the very logic central to the game.

I'm sure my views on simple scoring are well known by now, and I know they make sense to just about everyone to whom I have mentioned them.

I have long believed that someone forced up to 5 of a major (by the competitive bidding of their opponents) and makes contract should score slightly more than someone who bids 4 and makes 5, as the risk is obviously higher in the first instance.

However, one of the things I find equally inappropriate is the way in a teams match, a side winning more matches than another (and beating said team in the process!) can be placed below them! I'm not coming from a position of a whinging loser - quite the opposite, in fact!

In the recent SW Friendly Teams, played in Busselton, I thought that it was really unfair that the Webber side finished fourth in the tournament, having only lost one match (to the undefeated outright winners), while my team snatched the second place, prizes and glory, although we had lost twice - the second time, in fact, to Murray and Kate's team.

Can you imagine the furore in football, if - say, the Eagles - had only lost four times in the regular season, but were kept out of the finals by a team that had lost 6 or 7 times (including twice to West Coast) - merely because the Eagles had been thrashed 119 to 36 in one unlucky game, when everything went against them?

I know, I know! Some of you are saying "but Michael - those are the rules!" to which I would respond by reminding them of an old adage. "Rules were made for the guidance of wise men and the (blind) obedience of fools".

Rules they may be, but in my belief they are not in the best interest of fair play. I strongly believe that the scoring in "Teams" tournaments should be changed, and the winners decided by the team recording the <u>most</u> victories, and IMPs only used to separate teams with the same number of wins. Whatcha reckon?






# **Swan River Swiss Pairs**

Some weeks ago the West Australian Bridge column dealt with an opening preemptive from board one

from round seven of the Swan River pairs. I sought the advice of various experts as to how the bidding should proceed.

East opened with a bid of three or four spades.



#### From Fiske Warren

Bidding over pre-empts can be hard. Good judgment and luck are required in equal measure.

Over 3S, I confess I would try 4H. Obviously this could go horribly wrong but with 6-5 shape it often pays to be bold and I believe it is worth stretching. Partner has a monster hand and will check on Key Cards etc before bidding either 6H or possibly 7H.

If I were to pass 3S, I prefer 3NT to double on the other hand. It is then quite hard to bid accurately because partner has the perfect cards and the 3NT bid could have been based on a long club suit.

If partner doubled, I would have some catching up to do with my hand but it is not easy as partner could have a considerably less suitable hand. 5H feels about right.

But the problems I meet if I pass over 3S and partner bids are a good reason for bidding 4H in the first place!

What if the opponents open 4S? If I do bid, I try 4NT (2 suiter) but I am not sure I am strong

enough for that and my suits lack solidity. So I would reluctantly pass.

I play that partner's double of 4S shows a good hand with general values (not based on a trump stack). It tends to be balanced or 3 suited. I will often leave it in but will take it out if I am shapely (as here). We are on a guess how high to go. 4NT will elicit 5C from partner and we then have to decide between 5D or 6D.

I shall be interested to see whether your other consultants find it any easier!

**Chris Mulley** gave me a very comprehensive reply and his views, expressed below, are worth reading. All of them are in basic agreement on how to proceed, with minor conventional differences.

- (1) I'll start with the easy one first. Over the 4S opening I'm bidding 4NT, which Paul and I play as "takeout" when I convert 5C to 5D, I will be showing both red suits. This is a dead minimum hand for the action in terms of playing strength I wouldn't do it if I am vulnerable.
- (2) Over a 3S opening it's a bit tougher. Paul and I play a style of "takeout" double where I can double and convert at any level to show a hand with more than one place to play (i.e. it won't be strong and single suited), so I think I would venture a double on this as well, as no matter what level I convert clubs to diamonds. I will be showing both red suits. I'd like a few more high cards for the bid, but you can't have everything all of the time. Quite a few people play "equal level conversion", which is the same kind of idea, but only operates where you don't increase the level of the auction. That works fine here because the suit that you are promising (but missing) with your "takeout" double is clubs, so you are always converting at the same level.

I know some people play 4C/4D overcall on this auction as "non-leaping Michaels", which obviously works perfectly on this hand. It's based on the idea that a natural 4m overcall bypasses the most likely making game (3NT), so if you have that hand, you just bid 3NT regardless of whether or not you have a stopper. It sounds like it would lead to a good spot on the majority of

hands and ridiculous spots (often doubled) on the minority of hands. Having not played it myself, I'm not sure of the exact proportions of those results.

In the absence of either of those agreements, I think I'd go with Fiske's practical 4H bid. Even if I had 4NT "two suited" available, I don't think I'd use it here. If the lengths in the red suits were the other way around, I probably would (because I'm not crazy enough to overcall 4H on Axxxx) – if I play 5H, at least it will be in a fit.

(3) If I pass and partner doubles 3S, I have a tough decision. Presuming that I am playing with and against decent opposition, something very strange is going on. There hasn't been any raise over my pass by LHO, and partner also hasn't overcalled 3NT. So, at the table my guess would be that LHO has a weak hand with a big fit and really doesn't want us to bid slam. On that basis, I'd choose the huge overbid of 5NT "pick a slam", again planning on converting 6C to 6D to offer a choice between the reds. Given that I didn't choose 5S, partner will know that I don't have first round spade control, which might help him if he is thinking of potting the grand - with the hand he has, partner would surely bid seven: the hand I have is about the only thing I could have for the auction, although he might be a bit bemused by the fact that I hadn't taken an action with it initially.

I think Fiske's 5H bid is a good one – he's staying out of most of the slams that I am going to be in where they cash two aces or one ace and we have a slow red-suit loser.

I agree with Fiske that partner has a hand which should have overcalled 3NT rather than doubling. Again, Paul and I have some useful system here (that I stole from Tony Nunn and Sartaj Hans): we play "two-under transfers". The idea is that with big, flat hands, the 3NT bidder can either "super accept" (step) or accept the transfer. With a "trick source and a stopper", the 3NT bidder makes a "super-reject" of 4NT, and you can then bid accordingly (Pass is popular, and you've got out of the auction at the 4NT level). That would definitely get us to the small slam, and we'd have chances of bidding the grand.

(4) Over a 4S opening, Paul and I play a similar style to Fiske for a double – "convertible values" – a hand useful on both offence and defence. In my experience, the majority of top players play that

over pre-empts of 4S and over. The minority play it as pure takeout. I don't recall anyone who plays it as pure penalties (e.g. where you could do it on QJTxx and an outside card). The South hand is fine to make a double in our methods.

Opposite a "convertible values" double again I feel I have a choice between 4NT (2 spots to play) and 5NT (pick a slam). Given that I don't have the inference that I drew over the 3S opening available, I'm going to bid 4NT and follow up with 5D. I don't expect that partner will move with the hand that he has – I'd bid the same way without the two red aces, and from his perspective, even if I have one of the red aces, we are more likely than not to have a black suit loser that can't go anywhere.

I think it's probably wrong for me to bid like this. I have a hand where I would have taken action over the 4S opening, so partner is NEVER picking me for this hand, no matter how I now bid it. On that basis perhaps it's right to just go via the 5NT "pick a slam" or the 4NT followed by 6D, on the basis that you have a hand that is much better than anything that you can possibly hold. My projected auction for my choice has us playing a lay-down grand in 5D/5H, with no sensible way for partner to even bid the small slam. Of those two, given that I am following the "force to slam" path, I prefer an immediate 5NT bid, as it's less likely to cause an ethical problem if partner makes a slow 5-level bid.






# Calling the Director 101

This article is about how to call for the director. You

might think: "what's there to write about simply saying one word loudly?" Well, bear with me.

Here's a deal to illustrate how I think things should work:



You are South, and the uncontested bidding for East-West starts as follows:

WEST	NORTH	EAST	SOUTH
1D		1H	
4C			

East now pauses for quite some time, and bids 4H. Over 4H, West thinks for a bit, and emerges with 5H!

At this point, and without knowing what the East-West cards are, you are suspicious that West has used East's hesitation to decide to bid on, but you cannot know that for sure, nor do you know whether it's a winning move for the opponents.

I suggest that either you or your partner now say to East:

"Do you agree that you had paused over 4C?"

East will accept this to be the truth – it is fresh in everyone's minds, and no-one has accused anyone of anything.

The auction concludes as follows:

WEST	NORTH	EAST	SOUTH
1D		1H	
4C		4H	
5H		4H	
Pass			

You decide to lead a spade to 6H, and that powerful West hand gets put down on the table. Hmm, was that a clear-cut continuation over 4H? You don't need to answer that question ... just get on with the play.

#### Scenario 1

Declarer wins the spade lead, plays HA, CA to pitch the spade, and another heart up, thinks, and he puts in the queen (an error in theory, and as it turns out, also in practice), partner wins with the king, and your heart jack later takes the setting trick. Nice!

There is no need to take any further action. You don't have to call the director, or make a comment to the opponents like: "if you'd made it, you wouldn't have been allowed to keep it". You should say nothing – just take your +100 and be happy.

#### Scenario 2

Declarer guesses the hearts: HA, CA, and a heart ducked to partner's king, claim.

Call the director. But do it properly – say: "I'd like to get a ruling on this one". Don't be nasty about it and make accusatory implications about your opponents' ethics.

The director will come over, and you will relate what happened. Just the facts, nothing more, and including that East agreed that he had hesitated. *Don't argue your case.* There is no need.

The director might ask East-West some questions: for example, what did 4C mean? That will help him decide his ruling. But basically, the matter is now out of your hands, and you are no longer needed.

The director will leave and come back sometime later with a ruling. If he rules a return to 4H for 680, write the adjusted score down and say nothing. If he leaves the score at 1430, write the score down and say nothing. There is nothing to be said: the director gave a ruling, and if you don't like it, you can lodge an appeal after the session. The same applies to your opponents.

### **Summarizing**

You are not a policeman or the official Protector of Ethics. If someone does something doubtful, but it doesn't cost you on the scorecard, don't make an issue of it. In the vast majority of cases, the person is just an honest citizen who's come to have an enjoyable game of bridge. He hasn't come expecting to have his integrity questioned.

When a hesitation occurs, and the hesitator's partner subsequently takes a positive action,

confirm the hesitation with your opponents. This provides good protection for you in the event that your opponents may later deny the hesitation when the heat is on.

Only call the director when you have discovered that you might deserve an adjustment. Usually this is at the end of the play.

When the director arrives, don't get into a bridge argument with him or your opponents. It's terribly undignified. Just relate the facts, and let the director do his job.





# Losing Twice and Winning 12 Svelte Sally and the Girl's Best Friend

Your editor has stressed assertively to subtle Simon that he needs to be nice to his Partner. So Senior Serpent supervises this program, silently slipping along to the Club on Thursday afternoons.

Svelte Sally sits South, not savvy with that computer thing. Simon is, of course, computer literate and keyboard quick. He is therefore able to reinforce in his heart, the importance of being North.

The session goes well enough. Simon is being subtle enough. He tinkers with that little gadget, nobly refraining from his sometimes "75% to us. 25% to THEM".

Senior Serpent is alert as Simon picks up

SAQ6 HA98 D9 CKQJ1087

He deals and opens 1C. The opponents are silent throughout. Sally responds  $1 \spadesuit$ .

Hmmm ... it looks as though Sally might have to be the one to bid the ubiquitous 3NT; not a desired outcome.

Well ... do the right thing; 3C from Subtle Simon seems sound enough.

He awaits the verdict. Shock; horror. Svelte Sally is deep in trance mode. No!

She emerges ... SIX DIAMONDS!

West is near enough to impolite, flicking the King of Hearts on the table at about the same time as the bidding is over.

"Thank you Partner; nice hand" with just a little bat of the eyes and a winsome smile. "Ace please". It wins.

Not a moment of thought to consider and plan the hand, Sally calls, "King of Clubs, please".

Here is Svelte Sally's hand;

S973 H64 DAKQI10853 C-

Sally has played her H4 on the opening lead. East follows low on the CK from Dummy. Sally now discards her remaining H6, being chic in clubs. West flicks down the CA and "cashes" the Queen of Hearts as Simon sinks with just an imperceptible shake of the head.

Sally ruffs; "no Hearts, Partner".

Simon recovers; temporary reprieve?

Sally clears trumps in two rounds and claims; "my three of Spades to the Ace; my 7 and 9 of Spades away on the Queen and Jack of Clubs on Table, leaving me with only trumps.

Simon is now very polite to his Partner. He is lit up with a mile-high smile. "Well done, Sally" just sounds just a little reserved; faint praise?

Sally's women's intuition senses the drift. "Void in your jump rebid suit, Simon, it is not easy for me to bid 'scientifically'. I have to hope that they cannot cash 2 tricks before we take 12.

In any event, I can but hope you have at least necessary 2nd round controls".

"So you see, Simon; I was able to put your loser together with mine and so we are at one ... aren't we!"



## **Book Review**

# Getting into the Bidding – A bridge toolkit By Bill Treble Masterpoint Press 2012

A beginner quickly comes to the realization that much of the early bridge course material is only applicable to roughly 40% of boards played. One can get by with a rudimentary set of guidelines but for the majority of novices contested auctions are a battlefield full of landmines. This handy book by Bill Treble, a Canadian bridge player, sets out to give the budding novice a sound grounding in the use of these bridge tools to compete

effectively in today's game.

As one might expect the author lays a solid firm foundation in a broad discussion the principles of underlying a contested auction. In quick succession the opening distributional chapter handles types, Losing Trick Count, Takeout doubles. Overcalling, **Negative** Actions doubles. Delaved penalty doubles. Treatment of these topics is dealt from an historical perspective showing how modern bridge theory has developed over the years to cater for competitive element that nowadays is such a dominant feature.

The later chapters delve into specific tools and/or conventions that an intermediate/expert player


might well be expected to use against his opponents to gain the upper hand. The treatment of topics is detailed and thorough. The author is at pains to illustrate some of the pitfalls that can occur if the bidding tools are inexpertly applied. All the bidding conventions are liberally illustrated with examples and each chapter has a set quiz on the material. Quiz answers are fully documented and will be most helpful to the

reader in mastering the material.

One of the most interesting chapters is towards the end of the book where there is a discussion on High level Decisions. There is a look at the Law of Total Tricks and its limitations, Competition Raises, fit showing jumps and identification of Forcing Situations in a High-Level Auction. I found the discussion on the forcing situations particularly helpful, giving excellent guidance on how to handle these tricky situations.

All in all, a book that should well serve the needs of the intermediate

player who wishes to compete more competitively.



West continued hearts and South ruffed. The D4 from South went to the king and ace, West playing D2, reverse count. How should East continue?

Luckily for declarer, East did not notice dummy's spade pips. Had East returned a spade, declarer would be stuck in hand and bound to lose a club trick for one down. When East switched to a club, declarer took the finesse, cashed the CA, ruffed a club and took the spade finesse. Another club ruff left South's hand high. Next time East will check the spot cards more closely.

### Answer to the problem:

West's 2H was a pusillanimous effort. A jump to 4H is a better description of the shape and strength.

# **2013 STATE TEAMS SELECTION FORMATS**

## The Open Team

The 2013 Interstate Open Team Selection will be a 2 stage event. Stage 1 will consist of 6 rounds; IMP scored, to qualify 10 pairs OR 50% of the number of contending pairs\* (whichever is less) for Stage 2, a full Round Robin Butler. Stage 1 is open to all pairs. (Subject to normal BAWA requirements of financial status and a valid ABF number).

Pairs qualifying for Stage 2 MUST, at the end of Stage 1, declare their availability to play in the Open Team at the ANC in Adelaide. The pairs finishing 1<sup>st</sup> 2<sup>nd</sup> and 3<sup>rd</sup> in Stage 2 will be declared the 2013 Open Team.

Provided qualification requirements are met, the winning pairs will be eligible to play in other selection events, however, they will be NON-CONTENDING.

### The Women's Team

The 2013 Interstate Women's Team selection format will be a Butler style movement. The top 3 pairs will qualify for the Team. This event is open to ALL pairs (Women). However, Non Contending pairs\* must, at the start of the event, declare their status.

### The Senior Team

For players born before 1 January 1955; The 2013 Interstate Senior Team selection format will

be a Butler style movement. Note: It is the player's responsibility to ensure that they meet the age eligibility requirements. This event is open to ALL Senior pairs however, noncontending pairs\* must, at the start of the event, declare their status.

**STATE YOUTH BRIDGE**: For those under 26 on 1 January 2012. (Date to be confirmed)

A Youth Selection Event may be held in March; details to follow. Team members are likely to be required to participate in team training and coaching sessions.

Note: In **2013** ALL selection events mentioned above will have **Gold Point** status.

Dates for the events will be published as soon as the calendar is finalized. At this stage it is likely that Stage 1 of the Open event will begin late January, the Women's in mid-March and the Senior's in early April.

\* Contending pairs – A pair who warrants that they are available to play, at the ANC, in the event category relevant to the selection event. Noncontending pairs warrant that they are unavailable for selection in the team relevant to the selection event. Barring extra ordinary and / or unforeseen circumstances, penalties will apply should pairs change their contention status.

### Answer to the problem on page 16

#### **Interesting Hand from Tony Stevens**

This is the answer to the problem of how to make 6C with this hand when you seemingly have 2 spade losers.

To eliminate 1 spade loser you need to hope that the diamonds split 4/3 and that you have 4 entries to the East hand so that the fifth diamond provides a discard for the spade loser.

So say that a heart is led and that you win with the AH. Next cash the AD. The next play is the critical one where you lead the KH and ruff with the 4C. Next lead a small diamond and ruff with anything other than the 5C. Lead the 5C and win with the 7C. Another low diamond is led and ruff again. Next a low club is led to the JC which draws all trumps. Another diamond is led and trumped. Then a spade is led to the KS. The QS provides the entry to the fifth diamond and 6C is made. The key play is the ruff of a winning heart and the management of the club ruffs so that the J and 7C provides 2 entries to the East hand.
